- Completed application for membership
- Town of Coventry criminal history check (obtainable at Coventry PD--free)
- State of CT DMV Driving Record (obtainable via mail or at most DMV offices—fee applies, will be refunded if/when voted into membership)
- Copy of driver's license

When all necessary information is received, the membership committee will send a request for State of CT criminal background check.

Once all of the above is received, the membership committee will meet with the applicant.

After meeting with the applicant, the membership committee will present the application to the membership with its recommendation.

No member will accept any application for membership unless it includes all required documents.
